

# Special Revocable Permits

The Colorado State Patrol Port of Entry Branch Special Revocable Permit (SRP) Program supports safe and efficient commercial vehicle commerce within the state by issuing permits to qualified operators and companies. Operators and drivers may apply for an SRP to reduce the number of times required to clear a Port of Entry facility when the regularly operated route is within five miles but not does not pass a Port of Entry directory. Eligible applicants may receive a permit and comply with the conditions of the SRP program.

## 1) What is an SRP?

An SRP is a permit issued by the Colorado State Patrol Port of Entry Branch. §42-8-105 (4), CRS, allows the Port of Entry to issue an SRP to the owner or operator of any vehicle being operated over a regularly scheduled route.

## 2) Who is eligible to apply for an SRP?

Any owner operator of a commercial vehicle required to record a clearance under §42-8-105, CRS, who also is traveling a regular route and meets the eligibility requirements to participate in the SRP Program

## 3) Who is eligible to receive an SRP?

Specific eligibility requirements are provided in detail within the Port of Entry Size and Weight Rules, 8 CCR 1507-28. Summarized, to be eligible to receive an SRP, applicants must not have a significant history of violations of size and weight laws, clearance requirements or commercial vehicle safety regulations.

## 4) What is the primary benefit of an SRP?

An SRP allows for a vehicle that would otherwise be required to clear a Port of Entry facility by §42-8-105, CRS, to not do so.

## 5) Does a holder of an SRP never have to clear a POE facility or weight operation?

An SRP is issued for specific vehicles operated by a carrier and identifies a specific, *fixed*, Port of Entry facility. A holder of an SRP must record clearances quarterly with the vehicles assigned to the SRP at the facility the permit is issued for. The holder of an SRP must clear those port of entry facilities not indicated on a permit and to comply with direction to clear mobile Port of Entry weight operations where encountered.

## 6) How long are SRPs good for?

The Port of Entry is able to issue an SRP for a period up to three years. Standard SRPs may be issued for three years; Probationary SRPs are typically good for one year.

## 7) How do I apply for an SRP?

Applications can be submitted online using the CDOT COOPR portal, downloaded from the Colorado State Patrol Port of Entry Branch webpage or personally requested by calling either the Colorado State Patrol Port of Entry at 303-273-1870 or the SRP Program Coordinator at 303-273-1864.

## 8) How long does it take to get an SRP?

SRP applications may up to 21 days to process. Most applications can be processed in 7 to 10 business days.

Regularly traveling a route **within 5 Miles** of a Port of Entry facility?

Does the carrier have a **satisfactory** safety rating?
